**DEFINITIONS**

***Mountaineering*** - includes backpacking, ski touring, telemarking, cross-country skiing, rock climbing, hiking, waterfall ice climbing, glacier travel and high altitude climbing and travel.

**I AGREE TO THIS RELEASE OF CLAIMS AND WAIVER OF LIABILITY.**

I understand that mountaineering involves certain dangers, not all of which can be listed here. Among the more obvious and frequent are:

1. Steep terrain where a fall, whether roped or unroped, may cause injury and death
2. Falling rock, ice and other objects which may cause injury or death
3. Violent and unpredictable weather, which may cause injury due to extremes of heat or cold, and which may prevent travel to, from or within an area

4. Unfamiliar country, where the climber, skier or traveller may become lost, get off route or be separated from the rest of the party
5. Wild animals which have been known to maul, sometimes fatally, mountain travellers
6. Avalanches which are highly dangerous and may be triggered by the activities of skiers or climbers or by natural forces
7. Remoteness of location with poor communications and inability to get rescue or medical assistance quickly or easily
8. Medical problems and/or injury arising from climbing at high altitudes or in areas where adequate supplies of clean food or water may be unavailable. These include, but are not limited to: extreme heat and cold, frostbite, crevasses, avalanches, falling rock, high level physical exertion, altitude sickness (pulmonary and cerebral edemas), illness from local food and water, theft of personal equipment etc. neither AAP and/or AGL will be liable for any illness, injury or death sustained during the expedition, nor will AAP and/or AGL be liable for any uninsured losses of your property.

9. Transport by public or private motor vehicle, helicopter, and light fixed wing aircraft or through the use of animals.

In signing this document, I acknowledge and agree that: -

- I am solely responsible for arranging my travel to Lima to arrive on or before the start date of the expedition.
- I am not relying on any oral or written statements made by AAP or AGL or its employees, contractors or agents, whether in brochures, advertisements or in individual conversations to lead me to become involved in this program on any basis other than my assumption of the risks involved.
  - Should I cancel :
    - more than 60 days before departure - 30% of total price
    - 15 - 60 days before departure -50% of total price
    - less than 15 days = 100% of total price.Where departure date is deemed to be 5PM 17 June, 2012 - Auckland time. Cancellation must be advised in writing and will be effective from the date of receipt by AGL. Cancellation charges can often be covered by your travel insurance, provided the reason for cancellation falls within the terms of the policy.
- Whilst every effort will be made to adhere to the planned itinerary, it must be realised that with this type of adventurous travel changes to the itinerary may occur for which AGL accepts no responsibility, however caused. Circumstances may arise where we are forced to alter travel dates, duration, or hotel accommodation before your home. Expedition participants will be informed of any such changes as soon as we are aware of them.
- AAP is our Expedition Leader and they will do their utmost to ensure that any problems are solved for the benefit of the group as a whole. Submitting the signed booking form signifies your acceptance of the leader's authority to make decisions affecting the group or individuals. For instance, he/she may require an individual to leave the group if he/she believes that person's health is at risk, if an illegal act is committed, or their behaviour becomes detrimental to the safety, enjoyment or well-being of the group. Should AAP or AGL take such action, that person would not be entitled to any refund. Similarly, a client leaving the expedition en-route will not be entitled to any refund unless agreed by an owner of AGL.
- AGL cannot be made liable for the consequences of strikes, industrial action, wars, riots, sickness, quarantine, government intervention, weather conditions, or other untoward occurrences.
